### **8 SPECIAL REPORTS:**

#### **Investment Stats Report – PFM** 8.1

Mr. Wale Kajopaiye with PFM provided a report on the status of CAPRI's investment holdings. Mr. Kajopaiye noted that the investment portfolio remains consistent with CAPRI policy.

#### **Insurance Market Report – Alliant Insurance Services** 8.2

Mr. Doug Wozniak with Alliant Insurance Services provided an update regarding the current insurance market and outlook for 2023/24. Mr. Wozniak reported that we are heading into year 4 of a hard market cycle, making the renewal challenging. We may see another double-digit percentage increase in rates.

#### 8.3 **General Liability Program Status Report**

Executive Director Duarte reviewed and discussed the status of the General Liability Program. The total volume and frequency of claims made against CAPRI members has continued to trend down.

#### 8.4 **Property Program Status Report**

Executive Director Duarte reviewed and discussed the status of the Property Program. There was a slight increase in the number of property claims suffered by CAPRI members in 2021-2022. However, the severity decreased somewhat with only one excess claim incurred.



#### 8.5 **WC Program Status Report**

Executive Director Duarte reviewed and discussed the status of the Workers' Compensation program and provided highlights regarding current claim trends including frequency, severity, and claim closures. The Board was provided with a summary of the WC loss history by fiscal year.

#### **Investment Policy Review** 9.1

The Board reviewed the CAPRI Investment Policy and discussed whether amendments were necessary. This year, PFM noted a few minor edits and provided a redline draft of the policy for the Board's review.

#### 9.2 **Review of 2021/2022 WC Final Payroll**

The Board reviewed and discussed 2021/2022 Final Payroll for the Workers' Compensation program. CAPRI has now collected all final payroll and has calculated final premiums for the Program. As a pool, actual payroll totals decreased 2% as compared to the member estimates. This results in net refunds of approximately \$112,600 to members.
