# 9. DISCUSSION/ACTION ITEMS:

## **Excess Insurance Renewals**

Mr. Doug Wozniak and Staff presented and the Board discussed the status of the 2021/2022 insurance renewals. The Liability, Workers' Compensation (WC), and Crime Insurance renewal terms are set. However, we await updated/final premium numbers for the Liability and WC Insurance following our submission of amended exposure data. The Property Program renewal is still in negotiations, with wildfire coverage as the sticking point with insurance carriers.

### MOTION:

Director Michelle Lacy made a motion to provide Staff with authority to renew the following for FY 21-22:

- WC Program Excess Insurance policy with PRISM at an amount not to exceed \$824,488
- GL Program Excess Insurance policy with PRISM at an amount not to exceed \$1,291,933
- Property Program Excess Insurance policy with APIP at an amount not to exceed \$3.7M, with the following caveat:
  - Wildfire deductible of \$5M, with first \$150k covered by CAPRI
- Government Crime Insurance policy in the amount of \$17,654.

# 9.2 Proposed Revisions to GL & Property Memorandum of Coverage

Staff presented and the Board discussed proposed revisions to the GL & Property Memorandum of Coverage (MOC). The revisions stem from a recent change to the excess insurer PRISM's General Liability MOC, which excludes COVID-19 related claims. The proposed revision would write this coverage back into the CAPRI MOC with coverage up to the \$1M CAPRI pool limit.

Vice President Larry Mazzuca made a motion to accept the proposed change to the GL & Property MOC thereby excluding PRISM's exclusion for CAPRI's \$1M pool layer. Secretary Colin Miller seconded the motion.

# 9.3 CARPD Executive Director Services Contract Renewal
